	Vendor booths must be set up by 10:00 a.m. on Friday and cannot be taken down until after 12:00 p.m. on Sunday. WOW reserves the right to give booths that are not occupied by 10:00 a.m. on Friday to vendors on the waiting list.							
Purpose:	WINGS OVER WILLCOX (WOW) combines adventure, entertainment, and education to provide a weekend of birding pleasure for the novice, the expert, or the curious. Every year, hundreds of nature enthusiasts from around the world attend the birding and nature festival.							
Location:	Willcox Community Center, 312 West Stewart Street, Willcox, Arizona							
Vendors:	Any individual, organization, or agency having bird, nature, wildlife or related items or projects to display or sell. All merchandise is subject to approval and items/services not previously approved and listed on application are not allowed. <i>WOW is a non-political event and political statements and propaganda will</i> <i>not be allowed to be presented or sold in vendor booths</i> . WOW does not endorse the gathering of signatures on a petition or any activity to disseminate or promote political, personal, or religious beliefs.							
Registration:	Each exhibitor shall fill out the enclosed application form and return it to the WOW office with a fee of \$100.00 per booth space. (A \$50.00 fee applies to non-profit organizations that are not selling a product. Partner organizations and agencies are not required to pay a fee.) Booth spaces will be reserved in the order in which applications with payment are received. WOW and its partners receive priority in selection of the booth spaces. Booth space selection for vendors will be at the discretion of WOW after taking into consideration the vendor needs and choices. NO REFUNDS WILL BE MADE FOR APPLICATIONS THAT HAVE BEEN ACCEPTED BY THE WOW COMMITTEE. The WOW Committee reserves the right to reject applications.							
Booth:	Please do not alter or change the space and keep the walkways clear. The sizes of the booth space are noted on the attached map. Vendors requesting electricity will be provided one outlet per 200 watts for \$15.00. Vendors are responsible for bringing needed extension cords or power strips. Availability of electricity is limited.							
Equipment:	Some tables and chairs are available in the Willcox Community Center. They are the property of the City of Willcox and we use them with permission. If a table or chair(s) is required please note on the vendor application. Tables and chairs will be reserved on a first come, first served basis. Tables are provided for \$10 each with a maximum of two tables per booth. There is no charge for chairs.							
Identification:	Each booth should be decorated with an identifying sign, poster, or banner and/or business cards. Vendors should make every effort to post prices that are easily readable.							
Sales Tax:	All vendors selling products at the festival must have an Arizona sales tax license. A copy of that license should accompany this application. The sales tax rate in Willcox is 9.1%. For further license information please contact the Arizona Deptartment of Revenue at (800) 843-7196.							
Licenses:	All vendors selling products must have the appropriate state, county, and/or local licenses as required by law.
